**a) Brief details of litigation viz. name(s) of the opposing party, court/tribunal/agency where litigation is filed, brief details of dispute/litigation**

- (i) The Company has received Show Cause Notice (SCN) issued by Gujarat GST Department for the period July 2017 to March 2018 on various grounds. The total demand amount mentioned in SCN is Rs. 52.74 lakh.
- (ii) The Company has mainly replied to the State Tax Officer, Central/ State GST, Ghatak 45 (Vadodara), Range -12, Division 5, Race Course Circle, Vadodara vide its letter dated **October 30, 2023**, for extension of timeline upto 30 days for furnishing reply.
